Following the conference, three intacs events took place: a pilot training for Hardware SPICE, the Organizational SPICE Working Group meeting and the Executive Board meeting. During the conference, business packages were handed out to the Regional Representatives in attendance. The annual intacs dinner was also used intensively by the participants for personal exchanges. All discussions were important to get feedback and a mood survey on current topics such as the new training concept, new models, and extensions. We will process the feedback as part of our further planning and in discussions with our partners.

Intacs offers scholarship

The only requirement is that the topics are linked to SPICE or Process Management. Of course, intacs can also support in identifying an appropriate and interesting topic. The big advantage for the students is that they have the possibility to get in contact with process experts of the various topics quiet easily. The scholarship is funded with 500 EUR per month and will be paid for a duration of 12 months. The good news is for 2023 one scholarship is still left.

Status of intacs Working Group "Data management SPICE"

We are glad to have finished our first public version of the model. Thanks to all the support from the team we were able to release v1.1 in May 2023 (Link - please Login for Download).

A first pilot training and Gate4Spice Workshop caught the attention of quite a few interested parties. We got a lot of valuable information and feedback, which will lead to an updated version ideally by the end of 2023 with minor changes.

We plan to update the public training material and the associated exam by September 2023. First public trainings are now available in the market. Next year we will investigate in the alignment with Automotive SPICE 4.x.

Status of intacs Working Group "Agile SPICE™"

Agile SPICE™ Rollout

In March two pilot trainings including online exam took place with active participation. This enabled us to further improve the model, training material and exam questions. Due to the feedback, the Agile SPICE™ training was approved for general use and in the meantime numerous trainings from different training providers took place.

ECQA® acts as the certification body for Agile SPICE™ and conducts the exams online. Starting in July, certificates were sent out upon successful completion of the exam.

The participants and their companies benefit a lot from Agile SPICE™. They are specifically oriented towards the base practices of Agile SPICE™, which fits well with agile development in terms of structure and, above all, wording. The mapping to ASPICE® also allows projects to report progress in Agile SPICE™ and ASPICE® at the same time.

The Gate4SPICE meeting on Agile SPICE™ in May was well received. The results will flow into the next optimization cycles in 2023. In particular, an alignment with ASPICE® 4.0 is planned.

Status of intacs Working Group "Procedures"

The procedures work group is further strengthened to enhance the relationship to the Executive and Advisory Boards with Lars Dittmann – Vice President Intacs, officially has joined the workgroup.

In the last months the WG "Procedures" has worked on certain challenging reviews and documentation procedures to support the further structuring of the Association. The procedures and rules are revised in close cooperation with the Working Groups:

- Review of Training and Exam procedures and its translation to English. The scope of this document
 is to ensure planning, execution and monitoring of trainings and examinations in the context of the
 expert and assessor training.
- Development of Procedure for Release of Training course The scope of this procedure is to provide
 the definition of certificates that are formally provided by Intacs and to define rules for signature (both
 physical and digital).
- Development and Release of Procedure Approval Process The purpose of this procedure is to define the workflow of review and approval of new and modified work products for release and publication.
- Development of Procedure for Providing certificates
- Minor updates of existing forms and templates in addition to update on the naming convention

We would like to point out once again in this context that the business language of intacs e.V. is English. The reference of all documents is in English.

New intacs Working Group "Software Automation SPICE"

Purpose

The aim of this Working Group is to establish a process reference model as SPICE extension that is aligned with the ISO/IEC 15504:2012 standard and allows the determination of the capability level for the Automation of the SW development processes and supporting processes of a project.

The working group will also take care for the creation of the standard training material and the exam questions.

Motivation

In SW development and for all supporting processes Automation plays an increasing role. Examples for Automation are Test Automation (Software unit, integration, system test), Continuous Deployment and Continuous Integration, supporting processes, e.g., configuration management, etc. So far, no standard exists to check, how much is automated and how mature the Automation is. With the SW Automation Reference Model, it is intended to close this gap.

Development tools and methodologies provide and require an increasing support for software automation.

The software automation reference model does not depend on the used project model. Besides, software automation can be used at organization and at project level.

Benefits of using a process reference model (PRM) for software automation could decrease the effort and costs of the implementation of automation processes within projects and companies.

Current Status & Next Steps

Process reference models and the international standards have been analyzed. Current activities of the working group aim at establishing the structure of the envisaged process reference model. In the next phase, we plan to elaborate the first draft of the model.




Figure 1: Gate4SPICE event within the last years

News from Certification Bodies

News from ECQA

ECQA's mission is to provide Europe-wide certification schemes for people's competences and skills in numerous professions. Backed by a large, continuously expanding European and international network of both industrial and academic expert professionals and organizations in numerous domains, the ECQA fosters the elaboration and deployment of competence frameworks and skill cards, as well as their frequent adaptation to the rapidly evolving needs and requirements on the job market. Based on these competence frameworks and skill cards, the ECQA provides certification processes and facilities for currently more than 30 job roles in various domains.

The ECQA has built Focus Groups around strategic domains such as Accessibility, Cultural Heritage, Cybersecurity, Functional Safety, Innovation and Entrepreneurship, Mobility, Sustainability, etc. These European expert groups drive forward the filling of the skills gaps in existing and emerging job roles in their domains, as well as across those. ECQA board members have themselves expertise in at least one of these domains, allowing them to get actively engaged in defining the strategic direction of these groups.

Apart from certification, the ECQA also defines and verifies quality criteria for training organizations and trainers to leverage comparable quality levels of trainings across Europe and beyond. Furthermore, the ECQA also centrally promotes all certified job roles via newsletters, website, social media, and participation in dissemination events. So far, the ECQA GmbH has certified more than 10.000 professionals in Europe and beyond, they have had more than 15.000 candidates attending online skills browsing and exam facilities. They unite about 60 accredited VETs (Vocational education and training) as training bodies in 18 EU countries. The facilities are owned by the ECQA, and the premise is entirely independent form other beneficiaries and/or partner organizations in the consortium.

As a certification body ECQA works for intacs in organizing and certifying the exams for the non-automotive PAM (ISO/IEC 15504, ISO/IEC 33xxx, SPICE for IT Services, Test SPICE...) and new extension modules (Agile SPICE, Data Management SPICE). ECQA also is the certification body for the VDI (Association of German Engineers) and their Medical SPICE PAM.
